MEMORANDUM FOR COMMANDING OFFICERS OF MILITARY DEPARTMENTS AND
DOD COMPONENT INSTALLATIONS IN THE DUVAL,
FLORIDA WAGE AREA

SUBJECT: Nonappropriated Fund (NAF) Special Wage Rate Ranges – Duval, Florida
Wage Area #159

This letter amends the regular Wage Schedule #028 for the Duval, Florida wage area in accordance with the Office of Personnel Management letter dated March 23, 2005, which authorizes special rate ranges for certain skilled trades positions. The special rate ranges shown below have been established under the authority of DoD Instruction 5120.39 “Department of Defense Wage Fixing Authority – Appropriated Fund and Nonappropriated Fund Compensation Programs”, and 5 CFR 532.251 and 532.253.

These special rate ranges are authorized for Naval Air Station Jacksonville and Naval Station Mayport for grades NA-8, NA-9, and NA-10 in the following occupational series: Carpenter, 4607; Electrician, 2805; Maintenance Mechanic, 4749; Painter, 4102; Plumber, 4206. Special rates are also authorized for the corresponding leader and supervisory positions.

These special rate ranges conform with limitations contained in CPM 2010-22, dated December 27, 2010. The effective date is March 20, 2011. The order date for the 2011 wage survey was January 10, 2011.

The special rates amendment will expire when the next survey-based regular schedule is issued. In order to continue the authorization, affected components are required to comply with the provisions of Subchapter S12-6b of the OPM Operating Manual – Federal Wage System, Nonappropriated Fund.
