MEMORANDUM FOR COMMANDING OFFICERS OF MILITARY DEPARTMENTS
AND DOD COMPONENT INSTALLATIONS IN THE
WASHINGTON, DC WAGE AREA

SUBJECT: Nonappropriated Fund (NAF) Special Wage Rate Ranges – Washington, DC
Wage Area #124

Reference the enclosed special rate authorization letter amending the regular Wage Schedule #015 for the Washington, DC wage area, effective the first day of the first pay period beginning on or after May 2, 2003. That amendment is hereby superseded by the authorization below.

This letter amends the regular Wage Schedule #015 for the Washington, DC wage area in accordance with the Office of Personnel Management letter dated August 18, 2003, which authorized a special rate range for Custodial Worker, NA-3566-02, and extended the application of the previously established special range for Custodial Worker, NA-3566-01. The special rate ranges shown below have been established under the authority of DoD Directive 5120.42 “Department of Defense Wage Fixing Authority – Nonappropriated Fund Compensation Programs,” and 5 CFR 532.251 and 532.253.

Grade 2 special ranges are authorized for the Navy Exchange, Navy Lodge facility; the Air Force Services Squadron lodging facility at Bolling Air Force Base; all Army MWR facilities and lodging facilities at Walter Reed Army Medical Center and Fort McNair; and all lodging facilities operated by Navy MWR at Washington Navy Yard and Anacostia Naval Station.

The effective date of these rates is the first day of the first pay period beginning on or after the issue date of this letter. The special rates amendment will expire when the next survey-based regular

schedule is issued. In order to continue the authorization, affected components are required to comply with the provisions of Subchapter S12-6b of the OPM Operating Manual – Federal Wage System, Nonappropriated Fund.
