SUBJECT: Nonappropriated Fund (NAF) Special Wage Rate Ranges – Washington, DC
Wage Area #124

This letter amends the regular Wage Schedule #019 for the Washington, DC wage area in accordance with the Office of Personnel Management letters dated August 18, 2003, which authorized a special rate range for Custodial Worker, NA-3566-02, and extended the application of the previously established special range for Custodial Worker, NA-3566-01; and December 28, 2006, which authorized a waiver of the FY 2007 Federal Wage System pay limitation as it pertains to these special rates. The special rate ranges shown below have been established under the authority of DoD Directive 5120.42 "Department of Defense Wage Fixing Authority – Nonappropriated Fund Compensation Programs," and 5 CFR 532.251 and 532.253.



Grade 2 special ranges are authorized for the Navy Exchange, Navy Lodge facility; the Air Force Services Squadron lodging facility at Bolling Air Force Base; all Army MWR facilities and lodging facilities at Walter Reed Army Medical Center and Fort McNair; and all lodging facilities operated by Navy MWR at Washington Navy Yard and Anacostia Naval Station.

The effective date is October 5, 2006. The order date for the 2006 wage survey was August 1, 2006.

The special rates amendment will expire when the next survey-based regular schedule is issued. In order to continue the authorization, the affected component is required to comply with the provisions of Subchapter S12-6b of the OPM Operating Manual – Federal Wage System, Nonappropriated Fund.
